

**ORDINANCE TO SET TAX RATE  
WHERE M & O TAX RATE EXCEEDS THE ROLLBACK TAX AMOUNT**

Date: July 18, 2017

On this date, we, the Board of Trustees of the Springlake-Earth Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2017-18 at a total tax rate of \$1.17, to be assessed and collected by the duly specified assessor and collector as follows:

\$1.17, for the purpose of maintenance and operation, and

\$0 , for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE WILL EFFECTIVELY BE RAISED BY 6.8 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$130.00.**
